Publication Ethics and Malpractice Statement

International Frequency Sensor Association (IFSA) is professional non-profit international society for supporting researches and developments in physical and chemical, electrical and non-electrical sensors and biosensors. IFSA provides the best platform for the researchers, scientists industry professionals worldwide to exchange their latest findings and results, to discuss the recent progress in various areas of sensor science and technology. IFSA is publishing print and electronic books, newsletter and double-blind peer reviewed international *Sensors & Transducers* journal in both: print (ISSN: 2306-8515) and electronic (e-ISSN 1726-5479) formats. All related commercial activities are carried out by the IFSA Publishing, S. L.

IFSA Publishing upholds the best standard and takes all possible measures against publication malpractices. All books or book chapters, which is not in accordance with Publication Ethics and Malpractice Statement standards will be removed from the publication if malpractice is discovered at any time even after the publication. IFSA Publishing is checking all books and book chapter in a peer review process.

The Editorial Board is responsible for, among the other, for deciding which of the research book/chapter should be published and preventing publication malpractice. Unethical behavior is unacceptable and the IFSA Publishing does not tolerate plagiarism and double submission in any form.

1. Editors' Responsibilities

Publication Decisions: Editor should be accountable for everything published in the books and strive to meet the needs of readers and authors. Editors' decisions to accept or reject a book/chapter for publication should be based on the editorial board's reviews, book's importance and relevance to scope and topics.

Review of Manuscripts: The editor ensures that each manuscript is initially evaluated by the editor, who may make use of appropriate means, to examine the originality of the contents of the manuscript and ensure the quality of the material they publish.

Fair Review: Editor should strive to ensure that peer review at the book is fair, unbiased and timely. The editor ensures that each manuscript received is evaluated on its intellectual content without regard to authors' sex, gender, race, religion, citizenship, etc.

Confidentiality: The editor and any editorial staff must not disclose any information about a submitted manuscript to anyone other than the corresponding author, reviewers, potential reviewers, other editorial advisers, and the publisher, as appropriate. The editor must ensure that information regarding manuscripts submitted by the authors is kept confidential.

Disclosure and Conflicts of Interest: Editors should require reviewers to disclose any potential competing interests before agreeing to review a submission.

2. Authors' Responsibilities

Reporting Standards: Authors should precisely present their original research, as well as objectively discuss its significance. Manuscripts are to be edited in accordance to the submission guidelines for authors.

Originality: Authors must certify that their work is entirely unique and original.

Redundancy: Authors should not concurrently submit books/chapters describing essentially the same research. Submitting the same book to more than one publisher constitutes unethical publishing behavior and is unacceptable.

Acknowledgement of Sources: Author(s) should acknowledge all sources of data used in the research and cite publications that have influenced their research.

Authorship of the Book/Chapter: Authorship should be limited only to those who have made a significant contribution to conceiving, designing, executing and/or interpreting the submitted study. All those who have significantly contributed to the study should be listed as co-authors. The corresponding author should also ensure that all the authors and co-authors have seen and approved the final submitted version of the manuscript and their inclusion as co-authors.

Data Access and Retention: Authors should retain raw data related to their submitted book/chapter, and must provide it for editorial review, upon request of the editor.

Fundamental errors in published works: When an author discovers a significant error or inaccuracy in his/her submitted manuscript, the author must immediately notify the editor.

3. Reviewers' Responsibilities

Confidentiality: Manuscript reviewers, the editor and the editorial staff must not disclose any information regarding submitted manuscripts. All submitted manuscripts are to be treated as privileged information. Editors should provide guidance to reviewers on everything that is expected of them including the need to handle submitted material in confidence.

Acknowledgement of Sources: Reviewers must ensure that authors have acknowledged all sources of data used in the research. Any statement that an observation, derivation, or argument had been previously reported should be accompanied by the relevant citation. A reviewer should also call to the editor's attention any substantial similarity or overlap between the manuscript under consideration and any other publications of which they have personal knowledge.

Standards of Objectivity: Review of submitted manuscripts will be conducted objectively. The reviewers shall express their views clearly, with supporting arguments. Personal criticism of the author is inappropriate.

Promptness: If a reviewer believes it is not possible for him/her to review the research reported in a manuscript within the designated guidelines, or within stipulated time, he/she should notify the editor, so that the accurate and timely review can be ensured.

Conflict of Interest: All reviewers should have no conflict of interest with respect to the research, the authors and/or the funding bodies.

4. Change or Modification of Published Open Access Books and Book Chapters

Withdrawal: The published book/chapters will be withdrawn if the author(s) noticed significant errors. Before accepting the withdrawal request, the editorial board and Editor-in-Chief should discuss with the author(s) sufficiently. If the book/chapter is agreed to be withdrawn, the following should follow:

- The book/chapter in IFSA Publisher's database should be removed;
- The link in online publication site should be removed;
- Next phrase or similar phrase to announce the reason should be shown below the book/chapter title in online publication book list: (This book/chapter was withdrawn because of some technical errors).

Replacement: The published book/chapter can be replaced if the author(s) send an updated manuscript. Before accepting the replacement request, the editorial board and Editor-in-Chief should discuss with author(s) sufficiently, and at least two reviewers should check the changes. If the book/chapter were replaced, the following should follow:

- The book in IFSA Publisher's database should be replaced;
- Link in online publication site should be replaced;
- Next phrase or similar phrase to announce the reason should be shown below the book/chapter title in online publication book list: (This book/chapter was replaced because author(s) sent an updated version. Contact editor if you want to check the old version);
- Old version should be kept separately, and if someone wants to check the old version, the editor can send the PDF to him/her;
- Note that the replacement is acceptable only one time, and only for technical advances.

Removal: The published book/chapters will be removed if reviewers, readers, librarians, publishers or other subjects noticed a significant errors or plagiarism. Before removing a book/chapter, editorial board and Editor-in-Chief should discuss with authors sufficiently, and should provide enough time to have authors' explanation. If the book/chapter is removed, then it follows that:

- The book in IFSA Publishing's database should be removed;
- The link in online publication site should be removed;
- Next phrase or similar phrase to announce the reason should be shown below the paper title in online publication paper list: (This book/chapter was removed because of plagiarism).

5. Penalties

Double Submission: If double submission was found or noticed from other sources, the editorial board should check the status. If the double submission was confirmed as intentional thing, then the following actions must be imposed:

- Review process will be terminated;
- The reason should be sent to reviewers, editorial board and authors;
- All authors' name will be marked as black list, and these authors cannot submit any paper, chapter and book to all IFSA publications for two years.

Double Publication: If double publication was found or noticed from other sources, editorial board should check the status. If the double publication was confirmed as intentional thing, then the following actions will be carried out:

- This should be reported to editorial board and author(s);
- This should be sent to the publisher who published same (or very similar) chapter/book;
- Book/chapter will be removed according to the "Removal" part in section 4;
- All authors' name will be marked as black list, and these authors cannot submit any paper, chapter and book to all IFSA publications for two years.

Plagiarism: If plagiarism (including significant amount of self-plagiarism) was found or noticed from other sources, editorial board should check the status. If the plagiarism (including self-plagiarism) was confirmed as intentional thing, then the following actions will be carried out:

- This should be reported to editorial board and authors;
- This should be sent to publisher who published same or similar paper;
- Book/chapter will be removed according to the “Removal” part in section 4;
- All authors’ name will be marked as black list, and this author(s) cannot submit any paper, chapter and book to all IFSA publications for three years.

All the Editors, authors, and reviewers, within the IFSA Publishing agree upon standards of proper ethical behavior and accept the responsibility for fulfilling the following duties and responsibilities.
